The Mayor called the meeting to order followed by a word of prayer by Councilman Price and the Pledge of Allegiance to the Flag led by Mayor Rappold.

Because of the standing room only attendance at tonight's Council meeting the Mayor began by stating that the LGBTQ Ordinance was not on the agenda for tonight's meeting but will be on the January 8, 2019 agenda and if approved then, the second reading and a public hearing will be on the January 22, 2019 meeting. The Mayor added that at Council's last meeting a civility resolution was passed and it is his hope that everyone will remember this and will exercise civility in public discourse on all issues.

Council dispensed with the reading of the workshop minutes dated November 26, 2018, copies of which had been distributed to each member, and unanimously adopted the minutes as written on a motion by Councilwoman Worley and seconded by Councilwoman Bullock.

WHEREAS, the City of Beckley Firemen's Pension and Relief Fund Board of Trustees has designed and established a proposal for a Deferred Retirement Option Plan (DROP) in accordance with WV Code §8-22-25a; and

WHEREAS, the City of Beckley Firemen's Pension and Relief Fund Board of Trustees and the City of Beckley Fire Department have requested the Common Council of the City of Beckley to authorize the City of Beckley to submit the DROP proposal to the Municipal Pensions Oversight Board for evaluation and analysis by a qualified actuary and has requested the City of Beckley to reimburse the Municipal Pension Oversight Board for the actuarial costs for analyzing the plan.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL
OF THE CITY OF BECKLEY that the City of Beckley is authorized to submit the Deferred
Retirement Option Plan (DROP) proposal designed and established by the City of Beckley

A copy of the DROP proposal is attached hereto and incorporated into and made a part of this Ordinance.

This Ordinance shall become effective upon passage.

Next Mr. File presented for first reading an Ordinance authorizing the aquisition, planning, establishment, equipping and construction of a new fire station #3 by the Beckley Building Commission and authorizing the sale, issuance, and delivery of not to exceed \$5,000,000 Beckley Building Commission Lease Revenue Bonds. Mr. File read the Ordinance by title only. Mr. File introduced Mr. Ryan White and Mr. Mark Matkovich

will meet tomorrow for the first of three readings on this Ordinance. Mr. Matkovich stated this bond issuance is similar to the one that was done for the police department. He added the building housing station #3 has served the fire department for many years and is outdated. The new fire station will be in a better location and therefore provide for a quicker response time and will be closer to high risk properties.

On a motion from Councilwoman Bullock, seconded by Councilman Price, this Ordinance was unanimously approved by Council. Second reading and public hearing will be at the next Regular Council meeting on January 8, 2019.

Mr. John Zillinski, Director of the Emergency Operations Center, presented Council with a yearly update on the operations of the EOC for the year 2018. Mr. Zillinski introduced Cody Fortner who is the new Emergency Planner for the EOC. Mr. Fortner offered statistics on calls and services that were rendered by the EOC during 2018. The Mayor as well as Chief Christian and Chief Wills thanked them for their service to the City of Beckley.

There was no old business to discuss.

Under new business, Councilwoman Hunter advised Council that former Council Member Cedric Robertson was recently appointed to the Parole Board. Councilman Williams thanked Jerry Stump and the Board of Public Works for picking up the discarded remodeling trash that was in his neighborhood and hauling it away and also asked Mr. Cannon if he would take a look on 8th Street at all the trash being dumped there. Mr. Cannon will check on the possibility of obtaining and using cameras to catch anyone dumping trash.

Under public comments Danielle Stewart, who is a member of the Beckley Human Rights Commission, read a Resolution that the Commission adopted asking the City to consider passing an Ordinance protecting the LGBTQ community from discrimination in housing and employment. Ms. Stewart read the Resolution in its entirety. A copy of the Resolution is hereby incorporated into these minutes.

Ms. Upton suggested moving the venue to a different location that could accommodate a large attendance. The Mayor stated that has already been discussed. Beth Lewis of Beckley Derby Dames, Jessica Stagmeyer and Julie Gunnoe also spoke in favor of the Ordinance.

Councilman Sopher thanked everyone for coming to tonight's meeting.

The Mayor announced the next Council meeting falls on December 25, Christmas Day, and therefore there will be no meeting until January 8, 2019.
